- Reimbursement and payment for transportation and daily subsistence expenses incurred when traveling to the resort to begin employment and when returning to place of origin after completion of employment. Reimbursement for initial travel to the worksite will be included in your paycheck after completing 50% of your employment period. Payment for traveling expenses back to your place of origin will be included in your last paycheck.
- Reimbursement for all visa, visa processing, border crossing, and any other related fees, with the exception of passport expenses and other charges that are primarily for the benefit of the worker in the first week of employment
- All tools, supplies, and equipment required to perform the duties assigned

Additional Notes:

- 8-hour morning and afternoon shifts are available working 5 days per week. Shift schedules are agreed at the interviewing process according to employment needs and candidate's preference/availability.
- CS Grand Canyon Clear Sky Resorts will use a single workweek as its standard for computing wages due. All deductions required by law will be made from the worker's paycheck. Additionally, 50% of regular price for food, beverages, and retail consumed by employees will be deducted from their paycheck.
- Employees are expected to retain all related receipts and present them to CS Grand Canyon Clear Sky Resorts at the time of their arrival to the Resort's facilities for the reimbursement..
- Employees staying at the resort will not require transportation. Yet, employees who under unforeseen circumstances are required to travel for work related reasons to and from the worksite will be provided company transportation.
